## C1. Who we are and what we do

NHS Stockport Clinical Commissioning Group (CCG) is a clinically-led membership organisation, made up of the 50 General Practices in Stockport.

## Responsibilities

We are responsible for the local NHS budget. Our role is to understand the health needs in Stockport and use our funding to commission healthcare services that will meet those needs.


We will do this through the commissioning of local health and care services including:

- Elective (planned) hospital care
- Rehabilitation care
- Urgent and emergency care
- Most community health services
- Mental health and learning disability services

We will sometimes hold this responsibility alone, but in some areas we will work closely with our colleagues in the local authority.

## The new NHS in 2013 What it means for you


The changes in the NHS aim to empower patients and local clinicians to make decisions about NHS services in your area.

This infographic explains how the new NHS is structured








Stockport is divided into four localities that meet and work together through Locality Council Committees.



## C2. What we spend and how we spend it

### Financial information

## Pay grades

CCG roles are graded and paid in line with the NHS Job Evaluation Scheme (with the exception of Very Senior Managers and staff within the remit of the Doctors' and Dentists' reviews).

Within each pay band there are a number of pay points to allow pay progression in post. Progression through all incremental pay points in all pay bands are conditional on individuals demonstrating that they meet locally agreed performance requirements. For staff in bands 8C, 8D and 9, pay progression into the last two points in the band are annually earned, and only retained where the appropriate level of performance is reached.


