Unfortunately, but not surprisingly given the immense pressures in the NHS, the inverse care law is alive and well. It's particularly important we're mindful of ways to improve equity of access to services in a borough as polarised as Stockport, where healthy life expectancy in our most deprived areas is 55 years, compared to 71 years in our most affluent areas.

4. UPDATE: New advice and guidance Urology outpatient pilot starts Wednesday, 1 November

We completed a pilot at Stockport NHS Foundation Trust in June 2023, to review the impact of all referrals (excluding 2WW) sent which were automatically managed with advice and guidance, unless the consultant at vetting deemed the patient required a direct appointment. During the two week pilot, 56 advice and guidance requests were made:

- six were converted to routine referrals
- two were converted to 2WW referrals
- six requests for more information were made
- 42 returned with advice

Of those returned with advice, this included two requests to start medication and two to arrange an ultrasound scan.

Our view is that this approach ensures, as much as possible, the right patient is more likely to get the right treatment at the right time. We recognise concerns over increasing GP workload, however, this approach will hopefully minimise wasted time chasing referrals into urology. Additionally, for patients where reassurance only is given, we would dictate a letter to the patient to minimise the requirement of GPs to contact the patient and relay such information.

Given the way the urology on-call system works, the advice and guidance requests are managed by the HOT consultant of the week. Therefore, the maximum wait for a response would be seven days.

We are proposing another six month pilot to start on Wednesday, 1 November, during which time we hope to understand any further, unexpected issues. The Urology Advice and Guidance default offer at vetting pilot will commence from Wednesday, 1 November, 2023, to Wednesday, 1 May, 2024. During this period all routine and urgent Urology referrals sent to Stockport NHS Foundation Trust will automatically be managed with advice and guidance unless the consultant at vetting deems the patient to need a direct appointment to be allocated. GPs to continue to refer on the 2WW pathway as normal.

At present a new patient can be waiting up to 12 months for their first appointment. Providing efficient advice and guidance at vetting in a timely manner allows a patient to start a treatment pathway with the support of primary care colleagues much quicker. It is often found a patient at the initial appointment is assessed, started on treatment and discharged. Treatments

which could be provided via primary care with the advice of specialist consultants will ensure the highest clinical risk patients are seen sooner.

During this pilot it is crucial to measure the impact on primary care workload. Any feedback or data to understand the impact that this has (either positive or negative) would be greatly appreciated and can feedback to Simon Woodworth simon.woodworth@nhs.net or Stockport LMC nwch.lmcteam@nhs.net

5. UPDATE: Record achievement for Stockport practices in dementia reviews

Stockport GP practices have achieved record uptake on offering patients with dementia, a holistic face-to-face annual care review and development of a personalised care plan.

Figures, from the latest NHS Digital GP contract data on Quality Outcomes Framework (QOF) 22/23 dementia reviews, shows that the practice collective achievement has increased from 49% to 81%. The data shows that almost every practice in Stockport increased uptake from the previous QOF year, well above both ICB and national average.

This is on top of the record high achievements in 22/23 for Learning Disability and SMI (mental health) health checks. A key factor in reaching these levels is the invaluable support of the social prescribing, care co-ordinator and health coach teams who are able to coordinate, support and case manage these vulnerable patients to ensure we optimise their care.

This is testament to the hard work of Stockport GP practices and PCN staff who continue to consistently deliver some of the highest quality outcomes in the country alongside record high numbers of appointments and the highest overall patient satisfaction results in the North-West.

9. UPDATE: Breast Cancer Awareness Month toolkit

NHS England's national screening team has created some assets and content, including a toolkit for Breast Cancer Awareness Month, with the aim of encouraging more people to come forward for their first breast screening appointments.

Uptake amongst women attending their first appointment is less than 50 per cent, and therefore the key audience for the content and assets are women (age 50+). Studies show that if an individual comes for their first screening they are more likely to come forward for subsequent screening appointments.

10. UPDATE: Shingles vaccine programme update

UKHSA has produced a leaflet explaining why people have to wait for their shingles vaccine. NHS England has also updated the shingles toolkit with clear FAQs on eligibility at certain ages.

This update is due to reports of confusion around eligibility for the shingles vaccine programme following the changes.
